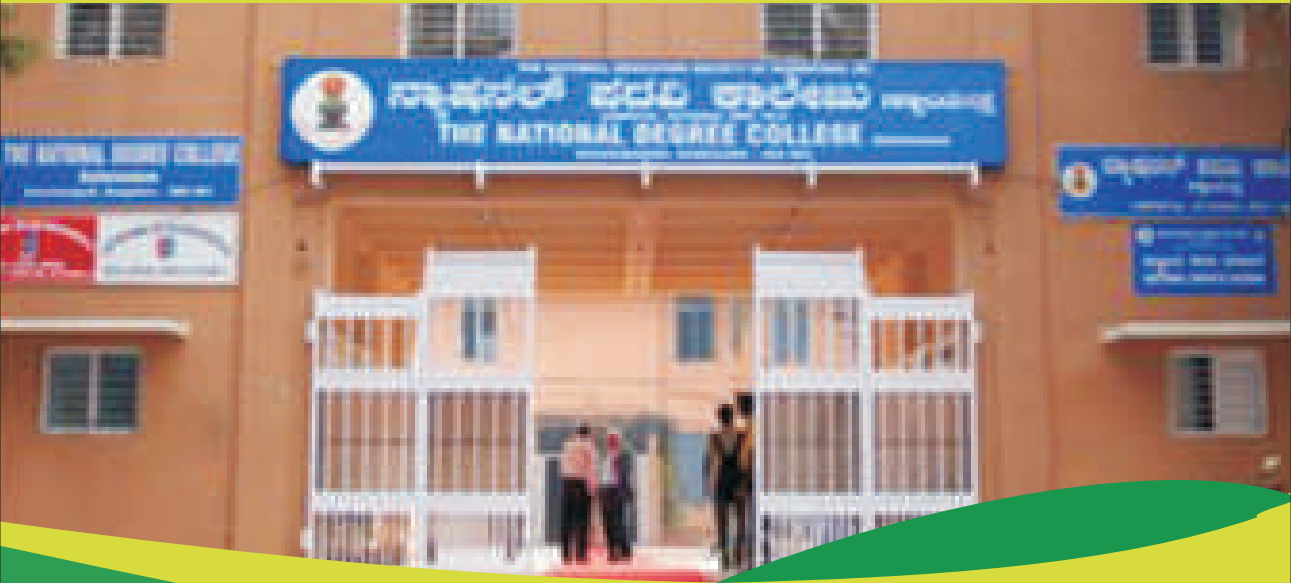

Dr. H. Narasimhaiah [1920-2005] was the President of the National Education Society of Karnataka. Dr. H.N. a great teacher, educationist and a man of scientific temper, rose to the zenith of his career by becoming the Vice-chancellor of the University of Bangalore. He was the recipient of 'Tamrapatra' award, He was also awarded 'Rajyotsava Prashasti'. The Kannada University D' Lit in recognition of his meritorious service to the cause of education. His autobiography 'Horatada Hadi' and 'Tereda mana' fetched him Karnataka Sahitya Academy Award. As an embellishment to all these, the Government of India conferred upon him 'Padmabhushana' award. Dr. H.N. was also the founder president of the Bangalore Science Forum [1962], which has won two national awards for popularizing science. He was responsible for starting the Bangalore Lalithakala Parishath (1992) and Sri B.V. Jagadeesh Science Centre at The National College, Jayanagar.

Dr. H.N. as an individual and an educationist set an example in public life by leading a life of simplicity.

Dr. H.N. showed continued concern and empathy for the poor and the downtrodden in society. He also inculcated the same values among his students by introducing 'value-based Education' as a part of curriculum. All the institutions of the National Education Society pledge to follow the philosophy and ideals which Dr. H.N. stood for.

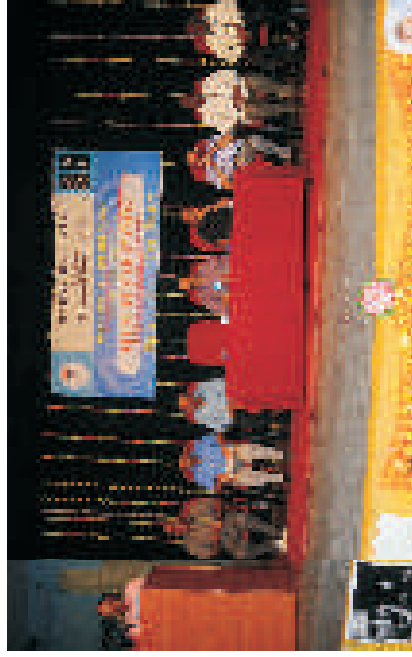

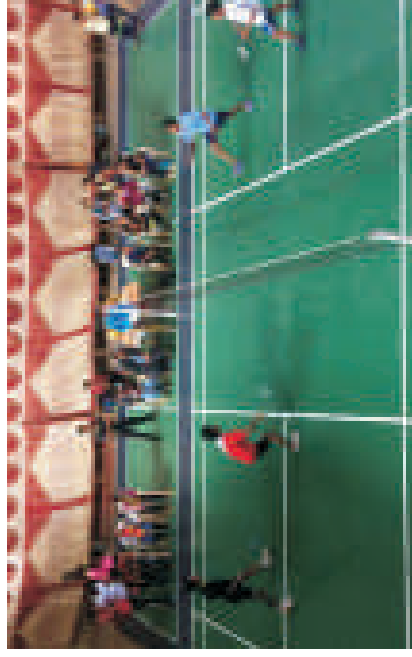

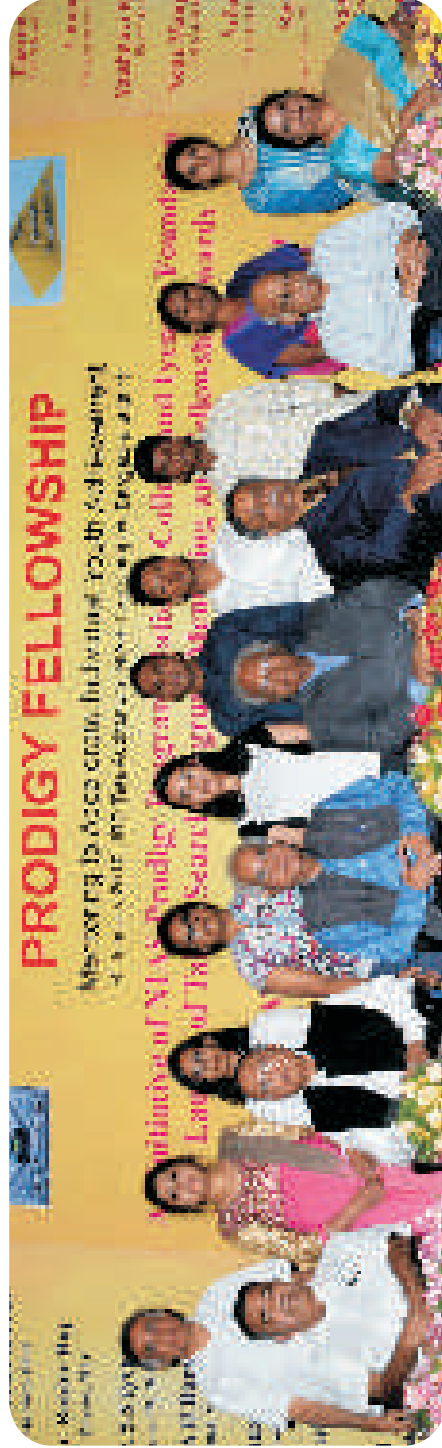

AUTONOMOUS STATUS TO THE COLLEGE

An important milestone in the history of the college is the grant of academic autonomy to the college by the University Grants Commission. A UGC committee visited the college in 2004 and after going through the past achievements and present potential of the college, recommended the college to be declared an Autonomous institution with effect from 2005-06. However, the college decided to implement autonomy with effect from 2006-2007.

Under autonomy the college is free to have its own academic calendar and programmes. Each department will have its own syllabus, ratified by the Board of Studies consisting of University nominees, Subject specialists from, the institutions of fame and members from high profile corporate sector. The college conducts the examinations as per the well-established norms and publishes the results. Any discrepancies will be attended to by the college administration. The college issues marks cards. However, the Bangalore University, based on the recommendations of the college, awards the Degree certificates. The University Grants Commission has granted only academic autonomy and not the financial or administrative autonomy.

The Autonomous Status granted to us has helped us to be eligible for various UGC grants. Infact the liberal grants sanctioned to our college by the UGC has helped us to provide varied infrastructural facilities to the college.

To function as an Autonomous Educational Institution is a big challenge as well as an opportunity to us in our untiring efforts to deliver the 'best' to the student community. Accordingly, we are equipped with the best infrastructure and the most advanced syllabi for all the disciplines. Educationists and Scientists of international repute are guiding our academic activities. Vastly experienced and dedicated teaching staff,

computerized library and state-of-the art laboratory facilities have been our main strength. We have well represented Botany and Zoology Museums. Keeping in mind the contemporary requirements, we have introduced additional subjects like Communicative English, Computer Basics, and Human Resources Management. The Industry-Institution linkage for interaction, training and placement centres are well within the reach of every student. To facilitate the all-round development of the student, encouragement is given to co-curricular and extra-curricular activities. The Bangalore Science Forum and The Bangalore Social Sciences Forum are the two fora housed in our college which enable the students to procure the latest knowledge in the fields of Science and Social Science. We are extremely happy with our experience of functioning as an autonomous college for the last ten years. Having upgraded our syllabi to meet an all- round development of our students, we feel proud to state that it has been quite a momentous beginning for us. We have conducted all the tests, examinations as per schedule. In consultation with the Industry leaders and the reputed academicians, we have been making our syllabus still more relevant. It has been to our credit that IT companies like Infosys, HP, TCS, SAP Labs come to our college and recruit many of our students. We are running seven add-on courses for Degree students. We are also running successfully seven P.G. Courses. (Kannada, English, Economics, Sociology, Computer Science, Electronics and Commerce) The National College, Basavanagudi, being an autonomous institution is the right place for the generation '**next**'.

SKILL DEVELOPMENT CENTRE

A Skill Development Centre has been established in collaboration with the National Education Foundation U.S.A., and State University of New York, The Centre will inculcate Training in IT, Soft Skills & Domain specific skills.

Major Highlights

- i) An online free training computer programme for teachers and students was conducted by the Department of Computer Science called the **HOURLY OF CODE** from 05-12-2016 - 11-12-2016. About 2000 students from Kindergarten to post-graduation participated in the programme. The department of Computer Science of the college is active in introducing students to such programmes.
- ii) The Bangalore University has recognized the Department of Kannada as a research centre. This is extremely useful for students who want to pursue Kannada Studies.
- iii) Our college has been recognized as a research centre by Florida State International University, USA for trans-disciplinary research and knowledge sharing programme.
- iv) A Science Talent Search Examination (Dr. Sadananda Maiya Master Mind Programme), on the lines of Westing House Model is being undertaken for the benefit of the students.
- v) Starting of a programme in Bio-Medical Science for the students of CBZ in collaboration with Edinborough Napier University, UK. It was resolved to go ahead with MOU and other necessary preparations to put this programme on board during the coming academic year.
- vi) The college has a state-of-the-art Language Laboratory which enables students to enhance their spoken skills. It also trains them to make presentations, to hold group discussions and to face interviews-all important areas for the job market. This facility is a semester long course, integrated into the curriculum and is compulsory for all streams in the V & VI Semesters.

- vii) The college has regular talks and lectures under the auspices of the Bangalore Science Forum, the Bangalore Social Sciences Forum and Sahithya Vedike that help students to expand their knowledge. Most of these talks are given by eminent speakers of the level of Nobel Prize Winners, FRS's, Distinguished Scientists & Scholars.

RULES AND CONDITIONS FOR ADMISSION

1. Application for admission in the prescribed form should reach the Principal on or before the due date specified on the college notice board.
2. **All the benefits and privileges extended by the Govt. to SC/ST/Cat-I and OBC students are made available to them in this college in respect of each course.**
3. Application should be accompanied by **attested copies** of :
 - a) Transfer Certificate from the Institution last attended.
 - b) Marks Card of the previous Examination
 - c) Latest certificates in the case of students belonging to SC/ST/CAT-1 2A, 2B, 3A, 3B, Group. OBC students should submit Income Certificate along with Caste Certificate.
4. Only attested copies of the certificates should be enclosed. The originals should be produced at the time of admission.
5. Students coming from other states must submit Migration and Eligibility Certificates.
6. Change of Optional subjects from Science to Humanities is permitted. However, no such change is permitted from the Humanities to Science subjects.
7. First year Degree applicants must choose the same language that they have studied in the previous class.
8. **ADMISSION FEE PAID WILL ON NO ACCOUNT BE REFUNDED.** The fee receipt should be preserved and produced on demand.
9. Names of students provisionally selected for admission will be notified on the college Notice Board and the Principal reserves the right of admission.
10. **ALL ADMISSIONS ARE PROVISIONAL AND ARE SUBJECT TO THE APPROVAL BY THE BANGALORE UNIVERSITY**
11. Incomplete applications will not be entertained.
12. **Students who have arrears of fees and shortage of attendance will not be permitted to submit their application forms to any of the qualifying examinations.**
13. Students selected for admission should affix a passport size photograph in their application and produce 2 extra copies at the time of admission.

INSTRUCTIONS TO STUDENTS

1. Students must attend classes regularly.
2. 75% attendance is compulsory for all the subjects (Both Theory & Practicals)
Students with less than 75% attendance will not be eligible to appear for the End Semester Examination. If a candidate represents the institution/State/Nation in Sports/NCC/NSS/Cultural or any officially sponsored activities he /she may be permitted to claim attendance for actual number of days participated, based on the authentic certificate of participation and recommendation of the Principal.

ADMINISTRATION

The College is under the general administrative control of the Governing Council of the National Education Society of Karnataka. All the teachers are members of the College Council of which a teacher is the Secretary.

PARENTS' COUNCIL

The Principal, the Secretary of the College Council and five parents invited by the Principal, constitute the Parent's Council. The Council meets often to discuss the functioning of the College.

STUDENT COUNSELLING AND GUIDANCE CENTRE

A student counselling centre is established in our college to provide personal care and assistance to the needy students for their alround development. Special lectures are arranged pertaining to career information, mental and physical health etc.

PLACEMENT CELL

The Placement Cell of our college organizes placement training and pre-placement seminars in the college. The reputed companies such as **IBM, TCS, WIPRO, HCL, iGATE, INFOSYS, SAP Labs, Tech Mahindra Mphasis, Accenture, Cognizant, Fidelity and Tally Solutions**, have conducted the placement drive in our college. The absorption rate has been more than 80% for BCA and 50% for B.Sc., B.A. & B.Com.

The cell also holds Workshops on Soft skills, Aptitude Tests, Communication Skill programmes with the help of Language Lab of the college.

LIBRARY

The College Library has been housed in the multi-storied building. The college Library consists of 90,000 books with an investment of Rs. 22 Lakhs. It is fully Computerized with Barcode system. Internet facility is also available. There is a qualified librarian in charge of the library. A well equipped Reference Section is housed on the first floor of the building. TERMS AND CONDITIONS FOR BORROWAL OF BOOKS

1. Students may borrow books from Monday to Friday
2. They may borrow two books at a time, on Barcode system.
3. A student should always possess the college identity card issued by the college. The same must be produced at the time of borrowing books, both from Reference and Borrowing sections.
In case of loss of the original I.D. Card, a duplicate I.D. card will be issued on payment of Rs. 200-00 only.
4. Books should not be sub-lent
5. Any damage or destruction to the barcode label on the book or I.D. Card

will involve a penalty of (Rs. 200-00) Rupees Two Hundred only.

6. If any damage or destruction to the book or other property belonging to the library is caused by the borrower, he/she shall be required to replace such a book or other property damaged, or pay double the cost. If any volume of a set of book is damaged, the whole set of books must be replaced.
7. Dictionaries, Encyclopedias and such other books are meant for reference only.
8. (a) Books must be returned to the library on the 15th day from the date of borrowing. If books are not returned within the due date, an over due charge of One Rupee per day per book (as indicated by the computer) will be collected from the defaulter.

b) Books from book banks may be borrowed for a period of one Year and they may return them at the end of the year.
9. (a) On the day of issue, he/she must inspect the pages and bring to the notice of the Library Staff any damage to the book that might have occurred already. Negligence to observe this rule will not be considered.

(b) Library dues must be cleared immediately. Failure to do so will disqualify students from appearing for the examination.
10. Under special circumstances the Chief Librarian reserves the right to re-call a book before the date of expiry.
11. Any difficulty or grievances felt in utilizing the library should be brought to the notice of the Chief Librarian.

REFERENCE SECTION

A selection of books for reference in all subjects is kept separately in the Reference Section on the I floor of the Library Block. Reference Section works on all working days from 9-30 a.m. to 5 p.m. and on Saturdays between 9-30 a.m. to 1-30 p.m.

- ❖ Students who obtain passing marks in theory but fail in practical need to appear for practical paper alone and vice-versa.
- ❖ Students who are absent for theory or practical paper in a subject have to take up only that paper.

5. Eligibility for admission to V Semester :

- ❖ Students who have cleared all the subjects of I & II semesters and should not have failed in more than 4 papers of III & IV semesters together shall be eligible for V semester.

6. Rules

- Provisional Results of each semester will be announced within 30 days after the completion of the examinations.
- Semester Marks Cards will be issued within 8 days of the announcement of results.
- A Supplementary Examination will be conducted for the failed students in each semester within three weeks after the results are announced.

- Supplementary exam is meant only for the students who fail in the Main exam.
- However those who do not qualify for the main exam, due to attendance shortage are not eligible for the suppl. exam. They can take the exam, only after ONE year. Students are requested to take serious note of this.

- Request for Re-evaluation should be made within 7 days from the date of issue of the marks card along with the fee notified by the Controller of Examinations.

B.COM COURSE REGULATIONS AND SYLLABUS

B.Com is a 3-year undergraduate course which helps the student to prepare for all the examinations including the Professional courses. This is a job oriented course with institutional training in Office/Factory/CA firms / ICWA and ACS Practitioners.

ELIGIBILITY FOR ADMISSION

- a) Candidates for admission to the B.Com Course shall have passed Pre-University course of Karnataka Pre-University Board or +2 of CBSE or any other State Board Syllabus securing a minimum 40% marks in aggregate.
- b) Completed 17 years of age at the time of admission or will complete this age on or before 31st December of the year of admission.

DURATION OF THE COURSE

The duration of the Course shall be for a period of three years. Examination shall be conducted at the end of 4 months on Semester pattern for the respective subjects.

Attendance :

- Each semester shall be taken as a unit for the purpose of calculation attendance.
- A student shall be considered to have satisfied the requirement of attendance for the semester, if he/she attended not less than 75% of the number of classes in theory and practicals separately, in each of the subjects.
- A Candidate shall be considered to have undergone the prescribed Course of Study if the candidate has attended at least 75% of the classes in each subject (Theory, Lab), otherwise the candidate shall not be allowed to appear for the End Semester Examination and has to repeat the Semester in the ensuing academic year.
- Marks for attendance under CIA [Continuous Internal Assessment] will be awarded in proportion to the attendance over 75%

EXAMINATIONS

The student will be undergoing a continuous assessment through his/her period of study. The evaluation will consist of internal examination, end semester examination, project evaluation and workshops for each subject based on the specific requirement of the respective subject.

CONFERMENT OF THE DEGREE

Candidate shall be eligible for conferment of the Degree by the Bangalore University, if he / she has undergone the prescribed Course of study for a period of 3 years and has passed the examination as have been prescribed.

B.C.A. COURSE

BCA is a Six Semester undergraduate technical course to train the students towards Application Software Development. The Autonomous Board of Studies in this college has designed an industry oriented syllabi which includes technologies like ●Net, Advanced JAVA, & Network Programming, etc.,

Regulations for Six Semester Degree courses under Autonomous Status : For B.C.A. Course

1. **Elibility For Admission :** A candidate with PUC or 10+2 or equivalent there to with a minimum of 40% of marks in the aggregate of all subject including languages is eligible for admission to BCA Course. Relaxation to SC/ST, Group I, be extended as per norms.
2. **ATTENDANCE :** A Candidate shall be considered to have undergone the precribed Course of Study if the candidate has attended at least 75% of the classes in each subject (Theory, Lab), otherwise the candidate shall not be allowed to appear for the End Semester Examinaton and has to repeat the Semester in the ensuing academic year.
3. **SCHEME OF EXAMINATION :** The Course is of Six Semesters. semesters I to VI are for Course work. The Project Work can be carried out either in the Institution or at an Industry/Research Organization. The guide will be one of the faculty members of the Department, approved by the Head of the Department. If the Project Work is carried out at an Industry/Research Organization, a Co-guide from the Industry/Research Organization, approved by the Head of the Department will supervise and guide the Project
 - (a) In each Semester (from I to VI) a student shall register for all courses of a semester prescribed.
 - (b) Internal Assessment of 30 marks each of the theory subject for which tests, each of 60 minutes duration shall be conducted spread over the span in a Semester.
 - (c) The Internal Assessment marks in Practical course are based on performance in the Laboratory and approach in solving the problem-awareness, progress, creative development etc. The Internal Assessment marks for Project work of a candidate is based on the solving ability, awareness, progress, involvement and is awarded by the Guide, Co-guide and Head of the Department.
4. **ELIGIBILITY TO GO TO HIGHER SEMESTER :** An Academic year consists of odd and even Semesters of that year. A candidate is eligible for promotion

to next academic year (starting with an ODD semester) provided the candidate has not failed in more than 4 subjects of the two Semesters of the just previous academic year and has completed all the examinations lower to the previous year. However, there is total mobility from odd to even semesters of any particular academic year. For example, a candidate seeking admission to 5th Semester should have passed all subjects up to and including 2nd Semesters and should not have failed in more than 4 subjects of 3rd & 4th Semester put together.

SPECIAL REMEDIAL COACHING CLASSES

Special Coaching for Weak students in English and Core subjects will be conducted althrough the year, to encoursage students for better academic performance.

INDUSTRY - INSTITUTION LINKAGE

The College has a linkage with industries and software companies to promote industry-institution relationship. This linkage will enable the students to have interaction with professionals for project guidance, on job training and future placement opportunities.

DUTY OF CLASS TEACHERS

Each class will be under the personal care of a class teacher. He or she will act as local guardian for students and take note of their regularity, discipline and academic progress. The class teacher will also monitor his/her students constantly.

MENTORING

The purpose of this system is to develop relationship between the teachers and the students. Each teacher will be in charge of about 30 students and will work for their academic excellence and also attend to their various problems.

GANDHI STUDY CIRCLE

Gandhi study circle was established in the college in 1966. It has a well equipped library on Gandhian Literature. The library consists of about 6,500 books. The Scheme of intensive Study of National Literature is facilitated by this collection. Many well-wishers have contributed money and books for the Gandhian Library.

N.C.C. AND N.S.S.

All able-bodied boys, except those students in the final Degree class, can join either N.C.C. or N.S.S. The college has been allotted one company each in Army Wing and Navy.

The National Service Scheme (N.S.S.) is an important wing. Both the boys and the girls of the college are eligible to join. The college has the right to reject admission to any student if his discipline is not upto the mark.

Further details about the enrolement, time table, discipline, etc. can be obtained from the concerned officers.

SPORTS AND GYMNASIUM

Facilities for playing Basket Ball, Cricket, Football, Volleyball, Shuttle-Badminton, Kabaddi, Kho-Kho, Athletics Ball, Badminton, Throw-ball, tennicoit, Soft-ball and Tennis are provided.

We have a well equipped multi-gym and fitness centre for the use of students and members of the staff. Qualified staff are on the faculty of Sports Department and they organise various sports events.

Kum. Vanita Memorial State level Inter-Collegiate Debate in Kannada is being conducted during the month of September every year. Debate is conducted separately for PUC and Degree students.

INTER-SECTION KANNADA, ENGLISH, HINDI AND SANSKRIT DEBATES

With a view to give an opportunity to students so as to develop their faculty of public speaking, the college has been conducting Inter Section Debate Contest in English, Kannada, Sanskrit & Hindi. Prizes are awarded to winners and runners up, individual prizes are also awarded.

BANGALORE SCIENCE FORUM SILVER JUBILEE INTER-SECTION LECTURE CONTEST

The Bangalore Science Forum, situated in the National college buildings, Bangalore-4, has instituted an Endowment of Rs. 5,000/- towards conducting the Bangalore Science Forum Silver Jubilee Inter-Section Contest in speaking on science subjects in Physics, Chemistry, Mathematics, Botany, Zoology and Psychology for Degree students.

THE NATIONAL COLLEGE HEALTH CENTRE

The National College Health Centre is housed in the enclosed Auditorium. Professional doctors conduct regular medical checkup. Personal Counseling by a Psychologist is provided on Saturday afternoon. First Aid facility is available on all working days from 10-30 a.m. to 5 p.m.

THE NATIONAL COLLEGE HOSTEL

The college has a hostel, located in the same compound. Board and lodging facilities are provided for 70 boys. The charges are fixed on a dividing basis. The administration of the Hostel is controlled by the N.E.S. The Principal is the ex-officio President of the Committee and a member of the staff shall be the warden.

AUDITORIA

The College has two large auditoria, each of which can accommodate about six hundred students. All important functions like, Inauguration of college activities, College Day, Drama Festival, Cultural Activities etc. are conducted in the Indoor Auditorium, which is also called Gandhi-Nehru Ranga Mandira. This auditorium has a big stage with a decorative outfits and side doors with ivory inlay. The other auditorium is an open air auditorium with a big stage.

Besides these two auditoria, the College has a large Multi-Media Hall named after Dr. H. Narasimhaiah. It is equipped with audio-visual facilities and has seating

capacity for 300 people. The Bangalore Science Forum and The Bangalore Social Sciences Forum hold their meetings, regularly, inviting eminent guest speakers for the benefit of general public & students. Dr. H. N. Multi-Media Hall is also utilised for conducting class socials, cultural and other educative programmes.

Regulations for the Two Years (Four Semesters) M.Sc Computer Science Course

Eligibility:

A candidate, who has passed the three year B.Sc Examination of any recognized University or equivalent thereto with Computer Science as one of the core subjects, shall be eligible for admission to M.Sc Computer Science Course.

- a) A General merit candidate should have secured at least 50% marks in aggregate and 55% in the Computer Science subjects in the degree course. For candidates belonging to SC/ST/BT and OBC, it is relaxed to 45% both in aggregate marks and marks secured in Computer science.
- b) Completed 20 years of age at the time of admission or will complete this age on or before 31st December of the year of admission.

2. Duration of the Course:

The course of study of P.G. Degree shall extend over a period of two academic years, each year comprising two semesters, each semester comprising sixteen weeks of class work. The terms and vacations shall be as notified by the college from time to time.

Medium of Instruction:

The medium of instruction and Examination shall be English only.

Attendance:

Each semester shall be taken as a unit for the purpose of calculating attendance.

A student shall be considered to have satisfied the requirement of attendance for the semester, if he/she has attended not less than 75% of the number of classes in theory and practicals separately, in each of the subjects.

A student who fails to satisfy the above conditions shall not be allowed to take the End Semester Examinations.

Marks for attendance under CIA [Continuous Internal Assessment] will be awarded in proportion to the attendance over 75%.

End Semester Examination:

Notification for the End Semester Examination will be issued 30 days before the commencement of the examination.

Students are required to pay the prescribed fee and submit the application form at the office of the Controller of Examinations (COE) within the dates notified.

Students, who do not pay the prescribed end semester examination fee for any semester, shall repeat the semester.

A student who has failed in a subject can attempt the same 3 times.

Practical examination will be conducted before the commencement of the theory examination.

Results:

Provisional Results of each semester will be announced within thirty days after the completion of the examinations.

Semester Marks Cards will be issued within 8 days of the announcement of results. Request for Re-valuation should be made within 7 days from the date of issue of the marks card along with the fee notified by the Controller of Examinations.

Failed candidates should appear for arrears as follows:

Odd Semester — — Next Odd Semester

Even Semester — — Next Even Semester

Students who have cleared a minimum of 4 papers of I & II semester together shall be eligible for III Semester.

Process of Assessment:

Examinations are conducted with utmost care in the college. The College conducts two centralized tests in a semester for 30 marks in each subject. The end semester examination is conducted for 70 marks in each subject. Practical examinations are conducted for 70 marks. 30 marks are allotted for internal assessment which takes into consideration marks obtained at the tests, practical tests, attendance and assignments. One minor project and two seminars are valued for 50 marks each. The internal assessment is calculated on the basis of the following points:

Attendance – 5 Marks

Assignments- 5 Marks

Two Internal assessment tests – (10+10) = 20 Marks

Total – 30 marks

The Institution monitors student progression by continuous evaluation of performance and attendance. The faculty guides students to ensure their progress at each stage.

The Internal Assessment marks must be displayed in the Department Notice Board and a copy of the same should be sent to Controller of Examinations, at least one week before the commencement of the End Semester Examination.

The attendance of the students is strictly monitored. The attendance status is announced at the end of every month. Parents of students having a shortage of attendance are informed by the class teachers. Students who do not have a minimum of 75% of attendance are not permitted to take the final examination.

There shall be a double valuation by Internal and External teachers. Average marks of both valuers should be taken as the marks secured for each paper. If the difference between the two valuers exceeds 15% of the maximum marks of the paper, there shall be a third valuation by a Board. Board should comprise of the Chairperson of the Department, Paper setter and an external member. Marks awarded by the Board shall be final.

ACT IV A
51 A FUNDAMENTAL DUTIES

- h) to develop the scientific temper, humanism and the spirit of inquiry and reform;
